

Strong words and sentiments at White Hart meeting

Strong opinions were exchanged at a meeting at Elm Farm on Thursday, 3rd March, to which villagers were called to save the White Hart from redevelopment into housing.

The 40 or so attendees comprised the campaign team, the pub's owner Stella Coulthurst and her partner John Trueman, CAMRA representatives, Richard Benyon MP and local residents.

In the chair, John Handy reported that an immense amount of work had been put in by the team against a hard deadline.

Anne Budd reported that applications would soon be submitted for granting the pub status as an [Asset of Community Value](#), and [local heritage listing](#) for the building itself.

Tom Lane and David Harris reported their findings in researching the potential commercial viability of the pub. Several similar rural pubs had been visited, their operators consulted, and the opinions thus garnered were in favour. It was estimated that, well run, the White Hart could generate a turnover of £520,000 to £570,000. Operating profit of between 8 and 10 per cent is the industry standard but, with a leasing rental of £55,000, this would make the enterprise marginal. It would be necessary to acquire the freehold.

WBC's own viability test, details of which are not publicly available, had also concluded that the White

Hart could operate viably as a pub.

John Handy concluded that there were two options for the village:

- 1) to work with the present owner to find a buyer;
- 2) to run the pub themselves.

It was revealed that two mystery benefactors had between them offered £60,000 to the project, but the terms and conditions of the offers (gift? unsecured or secured loan? equity investment?) were not made clear.

Stella Coulthurst was asked about the response to Christie's marketing of the lease. She reported that she had shown 10 interested parties around, but that none had followed up. She queried the team's viability claims on the grounds that finance charges could be as punitive as the leasing rental. She also pointed out that the freehold is not for sale, although she implied that if an acceptable offer were to be made, the sale would be subject to an [overage clause](#).

She also admitted that her own viability test of five years ago had proved wrong, costing her £500,000, as well as £100,000 invested by her partner John Trueman. The so-called "stripping of the kitchen" had involved the sale of some items to pay debts.

Other submissions to the meeting echoed familiar sentiments about what loss of the pub would mean to the village. Richard Benyon spoke briefly at the end, offering support.

John Handy wound up the meeting by asking everyone to complete a slip of paper asking for estimates of practical help and cash investment that each individual might be willing to offer. He also urged everyone to attend the WBC planning committee meeting, now rescheduled for Wednesday 30th March.

Acorn Ridge Cemetery for sale

Acorn Ridge burial site on Redhill, adjoining the village border, is up for sale with Clarke Gammon Wellers of Haslemere. Guide price for the 35 acres is £1,000,000. The website notes that since opening for business in 2008 there have been 131 full burials and 133 ash interments on the site, which has the potential for 30,250. Current gross revenues are quoted as running between £50,000 and £80,000 per annum.

The proposal to create the burial site caused much controversy and opposition in the late 1990s and early 2000s, with local residents fearing contamination of the river Enborne from lightly contained corpses (green burials were proposed, but were not guaranteed to be the only type of burial) and traffic jamming the narrow approach lanes.

i On Thursday 5th May the office of **Thames Valley Police and Crime Commissioner** comes up for election. The present incumbent is Anthony Stansfeld, who was elected in 2012. In August 2015 the office of the Thames Valley Police and Crime Commissioner was congratulated for having spent less than any other such office in England and Wales.

n Candidates for 2016 will be announced on Friday 8th April, and Monday 18th April is the deadline to register to vote: visit www.gov.uk/register-to-vote. Hamstead's polling station for this and for the **EU referendum** on 23rd June will be the village hall.

b **Little Sunflowers**, the preschool which has operated in the village hall for 10 years, will be leaving the village at the end of the summer term.

r In November the parish council heard a presentation from the national sales manager of **Gigaclear**, the company which is operating under contract to Superfast Berkshire to bring fibre-to-the-household broadband to Notspots. Another Chapel Corner crash

On a sunny February morning, the road was dry, and the temperature well above freezing, but yet another east-bound driver took Chapel Corner too fast, spun out of control, narrowly missed an oncoming car and crashed through a hedge and fence into a field. The driver was un-hurt, but the car was a write-off.

The event is all too familiar to local residents, who administered tea and sympathy to the two shocked drivers, but have little expectation of any remedy from WBC highways department, which appears to be at a loss to explain why this happens several times a year.

The same department recently claimed to have fixed the long defunct VAS near Spicer's Pond/Handys, but say that it was almost immediately disabled by some sort of collision.

St Mary's seeks survival mode

St Mary's Church has been suffering from dwindling congregations and – until recently – has had difficulty in recruiting volunteers to take on the offices of church admin. However, there is now an enthusiastic group of young parents supporting the family service, and the parochial church council has a new treasurer, Sam Keppel-Compton. A new church-warden is expected to be appointed soon.



With congregations sometimes down to single figures, and diocesan charges working out at around more than £500 per service, it is accepted that the status quo is not viable in the long term. Options for the future include becoming a chapel of ease, or being vested with the Churches' Conservation Trust. In the meantime, two services a month continue to be held, and two major fundraising events are planned for the coming months:
